However, Janet didn't give in and reiterated, "I'm sorry. I can't take your order. Please go back. You said your time was valuable. Don't waste it on Me."

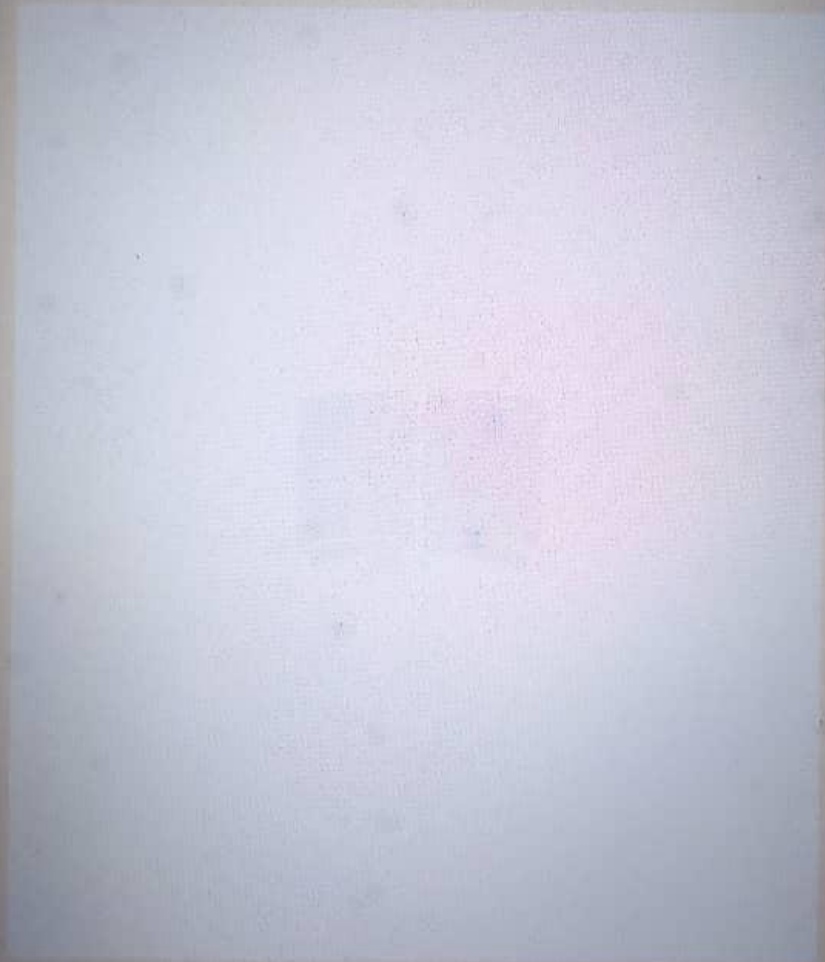
The influencer felt so embarrassed. Janet had not only confronted her, but also rejected her order several times and in front of a dozen of people. At this point, she had no choice but to leave.
